DIRECTIONS FOR USE

By law the user must take due care to avoid any unnecessary pain or distress in the treated animal when using the product in a manner other than as directed on the label.

It is an offence for users of this product to cause residues exceeding the relevant MRL in the Food Notice: Maximum Residue Levels for Agricultural Compounds.

Trim away the horn from the infected area until all the infection is exposed. Spray the hoof for 3-5 seconds holding the can within 15cm. Keep animal on clean, dry area for 10-15 minutes before returning to clean pasture

HAZARD

Extremely flammable aerosol. Causes serious eye irritation. Very toxic to aquatic life with long lasting effects.

PREVENTION

Read label before use. Read Safety Data Sheet before use. Keep away from heat. No smoking. Do not spray on an open flame or other ignition source. Pressurised container: Do not pierce or burn, even after use. Wash hands thoroughly after handling. Avoid release to the environment. Wear eye/face protection.

RESPONSE

IF SWALLOWED: Call a POISON CENTRE or doctor if you feel unwell. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists get medical attention.

STORAGE
