DIRECTIONS FOR USE

MILKING MACHINES - AFTER MILKING

1. Rinse plant with a minimum of 10 litres of cold water per cluster.
2. Wash with hot water (85°C) containing IMPACT RED (1 x 150g sachet per 200 litres of water).
3. Strip and brush any inaccessible parts. Wash thoroughly with cleaning solution and reassemble.
4. Prior to the next milking, rinse plant with cold water using compliant water only.
5. After rinsing, open plant to drain.

MILK SILO

1. Rinse silo with cold water using 4% of the silo volume then drain.
2. Wash with hot water (85°C) containing IMPACT RED (1 x 150g sachet per 200 litres of water).
 - Wash volume should be 2% of the volume of the silo
 - Minimum wash volume is 120L
3. Dismantle and brush any inaccessible parts eg valves, doors and seals.
4. Reassemble and flush with detergent.
5. Prior to the next milking, rinse silo with cold water using compliant water only.
6. After rinsing, open plant to drain.

ALKALINE WASH

1. Twice weekly (or more frequently if water quality or cleaning system requires it) use a hot alkali wash of FIL Impact Blue.
2. Follow the Impact Blue wash with an Impact Red wash using cold water.
3. Prior to the next milking, rinse plant with cold water using compliant water only.
4. After rinsing, open plant to drain.

HAZARD STATEMENTS

Causes serious eye damage. May be harmful if swallowed. May be harmful in contact with skin. May be harmful if inhaled. May be harmful if swallowed and enters airways. Causes mild skin irritation.

PREVENTION STATEMENTS

Keep out of reach of children. Read label before use. Read safety data sheet before use. Wear eye/face protection.

RESPONSE STATEMENTS

If medical advice is needed, have product container or label at hand.
IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Immediately dilute with 1 glass of water. Call a POISON CENTRE or doctor if you feel unwell.
IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. IF ON SKIN: Rinse with water. If skin irritation occurs, get medical advice.

STORAGE STATEMENTS

Store locked up.

DISPOSAL STATEMENTS

Dispose of empty containers safely in accordance with local regulations. Avoid contamination of any water supply with chemical or empty container.
PRODUCT DISPOSAL: Dispose of container and unused contents in accordance with local regulations. Keep records of date, time, quantity & location of discharge, name & address of user.
